8. School Improvement Plans review and updates
 - a. Goals
 - i. Raise proficiency levels in science, math, and language arts on RISE and ASPIRE tests by 2%
 - ii. Improve SEL measures on panorama survey
 - iii. Improve proficiency levels for SPED and ML learners on Utah RISE and ASPIRE tests by 2%
