 - a. Raise proficiency levels in Science, Math, and Language Arts on the Utah RISE and ASPIRE tests by 2% (LT and TSSA)
 - i. Reviewed testing data - PUT LINK HERE
 - 1. 7th grade proficiency decrease
 - 2. 8th grade proficiency on all RISE test increased by more than 10%
 - 3. 9th grade proficiency on all ASPIRE increase by more than 6%
 - 4. Overall proficiency increased
 - 5. Rise and Aspire tests are very different
 - 6. Aspire prepares students for ACT
 - b. Increase student SEL as measured by Panorama survey (TSSA)
 - c. Support ML and SpEd students (TSSA)
 - i. IEP student growth points have increase over the last three years
 - ii. Students have different TSI
 - 1. We are focusing on entire school
 - a. Vocabulary last year
